### 5.4 Electing BOM members and IC members term 2023-2028

- Mr. Nogami points out 3 changes in this electing:
- + 1<sup>st</sup> change: the quantity of IC members will decrease from 4 members to 3 members and the quantity still meets the regulation of company Charter.
- + 2<sup>nd</sup> change: the candidates for IC term 2023-2028 will include only members were nominated by VNPT and NTT Com, not include the members from PTF and PTI as before.
- + 3<sup>rd</sup> change: VNPT nominated 2 new members, Mr. Nguyen Duc Kien and Ms. Tran Thi Ngoc Linh. Mr. Kien succeeds to Mr. Nghia as candidate for BOM's member. Ms. Linh is candidate for IC's member.
